SUBJECT: Journal for month of December 1944

TO : COMMANDING OFFICER, 540th Engineer Regiment, APO #758, U.S.ARMY

Furnished necessary enlisted men personnel for the operation of the following Regimental Staff Sections, S-1, S-2, S-3, S-4, Personnel and Regimental Motor Pool. Operated showers for Officers and enlisted men as well as troops in surrounding area. Operating Regimental gas dump, which supplies an average of 4000 gallons of gas and oil daily to regiment. Operating three water points at the following places, Gerbeviller, Lutzelbourg, and Woerth, France, which supplies an average of 50,000 gallons of water per day. All trucks and air compressors dispatched throughout the month to battalions for road, bridge and construction work on all highways, as well as hauling material for fixed front line sites. Operating switchboard and maintaining telephone and signal communication for regiment. Operating Officers Rest Camp and mess at Mirecourt, France. Furnished daily guard for Regimental Headquarters and Company, as well as furnishing daily guard for Water Point. Moved from Gerbeviller, France to Lutzelbourg, France on 9 December 1944, in advance to set up site for Regimental Headquarters and our Company. Moved from Lutzelbourg, France to Woerth, France on 21st December 1944 in advance to set up site for Regimental Headquarters and our Company. Normal Regimental Headquarters and Service Company functions.

TO : C.O. 540th Engr. Regt., APO #758

During the month the S-4 Section requisitioned and issued to the Companies, all necessary rations, gas, oil, lubricants and anti-freeze. Tents and shoes in need of repair were taken into the Quartermaster Salvage Repair Company and repaired or exchanged and returned to the Companies.

The following items were procured and issued to the units within the regiment for the construction of Road Blocks and a main line of Defense:

All classes of property in need of salvage was taken in and about 98 percent replaced and returned to Companies. 360 Combat Trousers, 940 Trousers, Cotton Field, 812, Caps, Field and 1387 Hoods, Jacket Field M-43, 27 Tent Stoves, 21 Oil Burners and 8 Immersion type water heaters were requisitioned and distributed to the respective companies.

A Material in Hands of Troops was called for by S-4 in order that all existing shortages within the Regiment might be accurately ascertained. From the reports, requisitions were compiled and submitted to Army Depots and the following equipment was received:

## ACTIVITY JOURNAL

DECEMBER 1944

- Dec. 1 - 5, 1944 GERBEVILLER, FRANCE. Usual Regimental Personnel Section duties, personnel correspondence, and processing daily morning reports, G-1 reports and daily ration strength. Special Inventory of Medical Department personnel submitted to Hqs 4th MRU, in compliance with Letter 7th Army, dated 30 November 1944, Subj: Special Inventory of Medical Department Personnel. S/Rs and allied papers of 8 EM missing during training operations sent to AG 7th Army, Casualty Section. Prepared S/Rs and allied papers of 6 EM returning to States on TD. Requisition submitted to Hqs 7th Army for unfilled rotation vacancies.
- Dec. 6 - 11, 1944 GERBEVILLER, FRANCE. Usual Regimental Personnel Section duties, personnel correspondence and processing daily morning reports, G-1 reports and daily ration strength. Processed PTAs. Submitted roster to S-1 on Officers transferred out of Regiment since its activation. Personnel Section moved to LUTZELBOURG, FRANCE. Tec 4 Ernest H. Luehring awarded Bronze Star per G.O. 117, Hqs 7th Army, dated 30 November 1944.
- Dec. 12 - 18, 1944 LUTZELBOURG, FRANCE. Usual Regimental Personnel Section duties, personnel correspondence, and processing daily morning reports, G-1 reports and daily ration strength. Submitted Personnel requisition to Hqs 7th Army to effect return of Hospitalized personnel who have been dropped from rolls. Prepared Officers pay vouchers, and Enlisted Mens payroll for month of December, signatures obtained and submitted to Finance Office. Letter "Report of Death" submitted to Casualty Section, 7th Army on Pvt Paul C. Arnold a non battle casualty. All Deductions and Allotments discontinued and DD payroll prepared and submitted to Finance Office on Pvt Alphonse Piro of Co. "A", per General Court Martial # 614, Hqs P.B.S. dated 30 November 1944.
- Dec. 19 - 23, 1944 LUTZELBOURG, FRANCE. Usual Regimental Personnel Section duties, personnel section correspondence, processing daily morning reports and G-1 reports, and daily ration strength. Captain A.D. Gavura placed on TD in Paris, France to attend Army Information - Education Staff School per Ltr Orders Hqs 7th Army, 14 December 1944. Captain T. F. Clifford appointed Class "A" Agent of Major O.C. Culbreth FD, 26th Finance Disbursing Section. Final Statement on Pvt Paul C. Arnold Co "B", deceased, submitted to finance. Major Albert B. Smith returned to regiment after having completed his TD in the states. Major Smith returned to this regiment per SO 157, Hqs 7th Army dtd 29 August 1944. Personnel section left Lutzelbourg on the 21st and after some confusion as to where Headquarters should be, the town hall in the town of Woerth, France was finally picked for Regimental Headquarters and by evening of the 23rd the Personnel Section was set up and operating.
- Dec. 24 - 31, 1944 WOERTH, FRANCE. Usual Regimental Personnel Section duties, personnel correspondence, and processing daily morning reports, G-1 reports, and daily ration strength. Received replacements for 11 rotation vacancies. Captain Andrew D. Gavura returned to regiment from TD in Paris. Picked up 5 EM at replacement depot returning from hospital. Captain Thomas G. Hudson and Tec 5 Charles J. Bay killed in action by enemy planes. Captain Donald E. Casey designated assistant S-3 of regiment, vice Captain Edward L. Fizdale transferred to 1175 Engr (C) Gp per Subject: Orders, Hqs 7th Army dtd 2 January 1945. Captain Frederick C. Woods designated Executive Officer of 1st Bn, vice Captain Donald E. Casey relieved. 1st Lt Guy F. Coons designated Commanding Officer, Co "C", vice Captain Frederick C. Woods relieved. Enlisted men's payroll and Officer's vouchers for month of December paid. Lt Roy N. Thompson designated Commanding Officer of Co "E", vice Captain Thomas G. Hudson deceased.
